Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and non-financial companies.</li> <li>Sunrise Bank does not share with nonaffiliates so they can market to you.</li> </ul>	
Joint Marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Sunrise Bank doesn't jointly market.</li> </ul>
